## **ARTICLES OF INCORPORATION**

OF

### HOPKINS SQUARE PLAZA, INC.



The undersigned, desiring to organize a corporation under Chapter 607, Florida Statutes, sets forth the following:

### ARTICLE

The name of the corporation shall be **Hopkins Square Plaza**, **Inc.** The address of the principal office of the corporation and the mailing address of the corporation is **849 Sawyer Run Lane**, **Ponte Vedra Beach**, **FL 32082**.

The duration of the corporation shall be perpetual.
