

ARTICLES OF INCORPORATION

Arroyo Leon, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE I - NAME

The name of this corporation is: Arroyo Leon, Inc.
