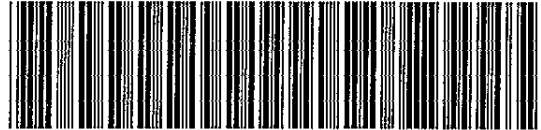

THE UNDERSIGNED INCORPORATOR, for the purpose of forming
corporation under the Florida Business Corporation Act, hereby adopts the following
Articles of Incorporation.

ARTICLE I. CORPORATE NAME.

The name of this corporation is GOTTA SKATE, INC.

ARTICLE II. PRINCIPAL OFFICE.

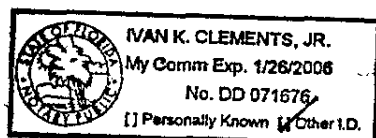
