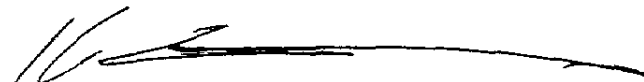

ARTICLE I- NAME

The name of this corporation is KIRK A. BARROW, P.A.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all-lawful business as a professional attorney.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock, which shall be designated as "Common Shares."

ARTICLE V - PRE-EMPTIVE RIGHTS

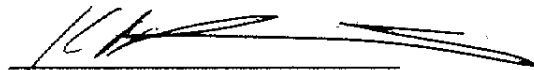
ARTICLE IX – INDEMNIFICATION

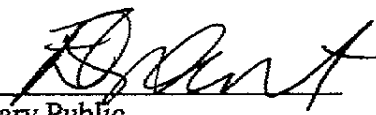

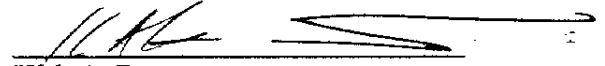

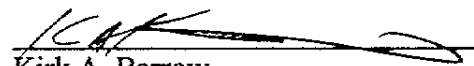
