### ARTICLES OF INCORPORATION

OF

The undersigned incorporator does hereby make, subscribe, file and admowledge these Articles of Incorporation for the purpose of organizing a corporation under the Floridz Business Corporation Act.

### ARTICLE I

## NAME OF CORPORATION

The name of this Corporation shall be:

## ARTICLE II

#### PRINCIPAL OFFICE AND MAILING ADDRESS

## **AUTHORIZED SHARES**

The total authorized capital stock of this Corporation shall consist of 10,000 shares of Common Stock, par value \$0.01 per share. As and when dividends are so declared and paid, the holders of Common Stock shall be antitled to participate in such dividends ratably on a per share basis. In the event of any liquidation, dissolution or winding-up of the Corporation, whether voluntary or involuntary, the holders of Common Stock are emitted to share ratably in the net assets, if any, ranalning after payment in full of all debts and liabilities of the Corporation and after the holders of any outstanding class or series of capital stock ranking senior to Common Stock shall have been paid in full the amounts to which such holders shall be entitled, or an amount sufficient to
