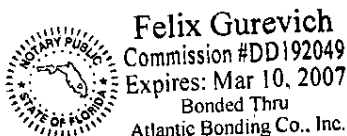
1. Stephanie M. Hughes is the President of GLOBAL CONSULTING & MARKETING CORP., a Florida corporation, (hereinafter "Corporation").
