

ARTICLES OF INCORPORATION OF MOPS, BUCKETS & STUFF CLEANING SERVICES INC.

The undersigned, being above the age of eighteen (18) years and competent to contract, for the purpose of organizing a corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

ARTICLE I

NAME

The name of this Corporation shall be MOPS, BUCKETS & STUFF CLEANING SERVICES INC., and its principal place of business shall be located at 6907 Sawmill Blvd., Ocoee, Florida 34761.

ARTICLE II

COMMENCEMENT OF CORPORATE EXISTENCE

This Corporation shall commence corporate existence on the date of filing these articles of incorporation with the Florida Department of State, and shall have perpential existence unless sooner dissolved according to law.

No shareholder of the Corporation shall have the right, upon the sale for each or otherwise, of any new stock of the Corporation or of any stock of the Corporation held by it in its treasury or otherwise, of the same or any other kind, class or series as that which he already holds, to purchase his pro rata or any other share of such stock at the same price at which it is offered to others or at any other price.
