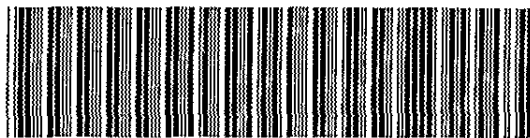

ARTICLE I - NAME

The name of the corporation is C & C ELECTRIC WORKS, INC..

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of execution and acknowledgement of these Articles.

ARTICLE III - PURPOSE

The corporation is organized for the following purposes:

- A. To engage in the business of selling, maintaining and servicing pumps and pumping equipment.

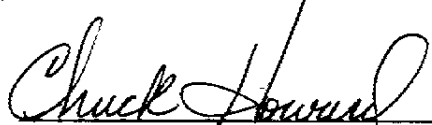
