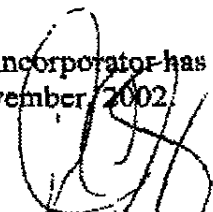
Article IX

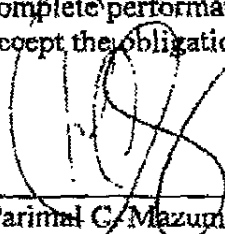
