Articles of Incorporation of G. Severt, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

Article I Corporate Name. The name of the corporation is G. Severt, Inc. (the "Corporation").


The Board of Directors from time to time may move the Registered Office to any other address in the State of Florida.
