ARTICLES OF INCORPORATION (PROFIT)

Rene J. Clavareza, the undersigned, being of the age of eighteen (18) years or more does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida.

- 1. The name of the Corporation shall be: guiadearmas corp.
