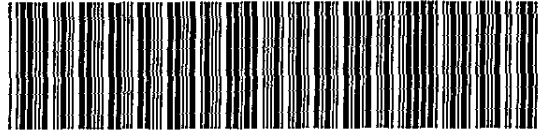

ARTICLE X




