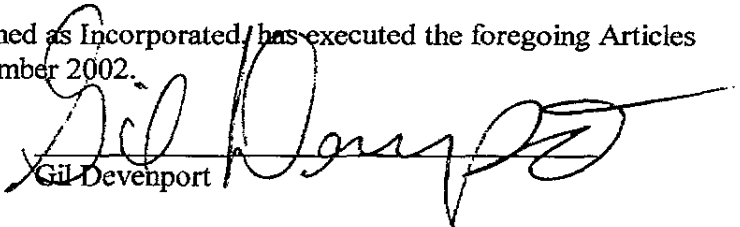

AMENDMENTS**

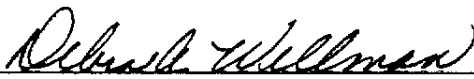

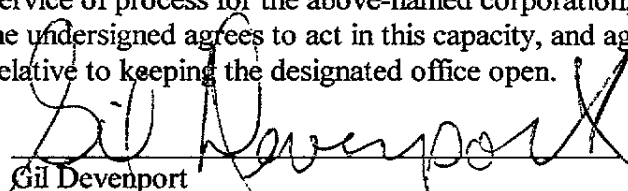
