The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I -- NAME OF CORPORATION

The name of this corporation is **SHRIVANI**, **INC**. and its principal place of business shall be located at 3285 Bodmin Moore Dr, Tallahassee, Florida 332317-9006.

ARTICLE II -- TERM OF EXISTENCE
