#### ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

#### **ARTICLE I - NAME & ADDRESS**

The name of this Corporation is **WIZARD PRODUCTS**, **INC**. The principal office, if known, or the mailing address of the Corporation is 4125 Dora Wood Drive, Mt. Dora, Florida 32757.

#### **ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III - PURPOSE

The general purposes for which the Corporation is organized are the following:
