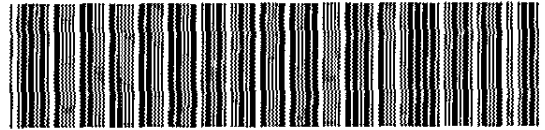

**ARTICLE I. CORPORATE NAME**

**ARTICLE III. CAPITAL STOCK**
