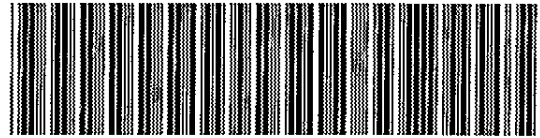

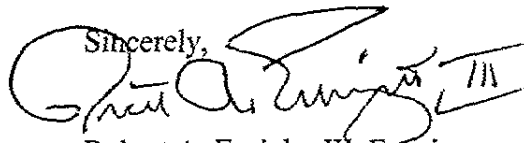

The undersigned, for the purpose of forming a for profit corporation under Chapters 607 and/or 621, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Incorporation.

ARTICLE I – NAME

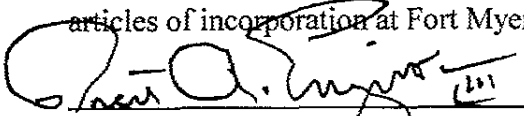
