All corporations that are authorized to transact business in the State of Florida must file a yearly Uniform Business Report (UBR). The UBR contains information such as the mailing and principal address of the corporation, the registered agent and its address, the current officers/directors of the corporation, as well as their addresses, and the corporation's Federal Employer Identification number. The report is due in January of each year (regardless of the date of incorporation) and considered late after May 1st.

You can make a written request for a waiver of the late fee. Attach the request to a completed UBR, and submit with \$150. The request will be reviewed, but it is not a quarantee the request will be honored. If the late fee is required, you will receive a letter advising so.
