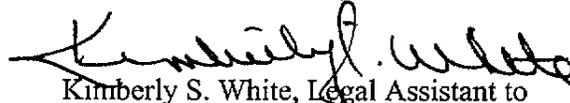
Sign the Articles of Incorporation as indicated in the presence of a notary public and have them notarized. Take the original and one copy to the Secretary of State, Division of Corporations, at 409 East Gaines Street, Tallahassee, Florida together with your check for \$78.75 for filing. They will file the corporation for you and give you back a certified copy of the Articles of Incorporation.

1. Have all parties sign the Organizational Minutes of the corporation.
2. Complete and sign the Form SS-4 Application for Employer ID Number and call the telephone number provided for the IRS. They will ask you a series of questions from the form, and then give you your new Federal Employer I.D. Number. Fill that number in on the form, make a copy, and send the original of the form to the IRS in the envelope provided. **YOU CANNOT USE THE OLD FEDERAL EMPLOYER ID NUMBER YOU HAD FOR YOUR PREVIOUS CORPORATION; THIS IS NOT THE SAME CORPORATION EVEN THOUGH IT HAS THE SAME NAME, AND DOING SO WILL CAUSE YOU TROUBLE WITH THE IRS.**
3. Complete and sign the Form 2553, Sub-S Application, and send it to the IRS in the envelope provided.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is AL HANCOCK, CONSTRUCTION, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III - TERM OF EXISTENCE

This corporation shall commence its existence as of filing.

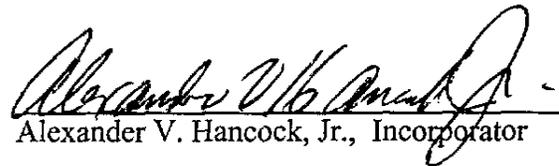
ARTICLE VII - INDEMNIFICATION

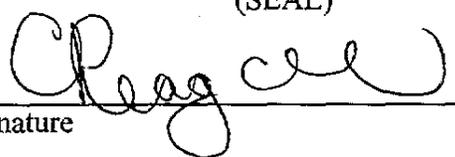

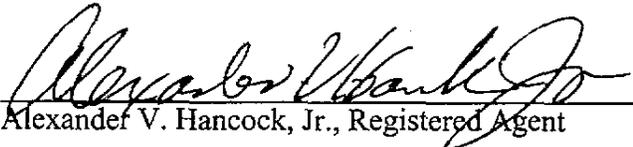
