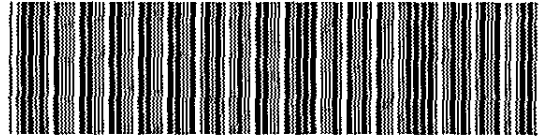



ARTICLE ONE

The name of the corporation is SKILLED CONSTRUCTION SERVICES, INC.



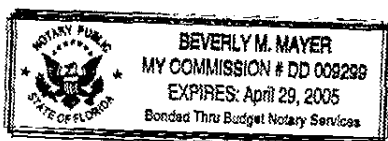


