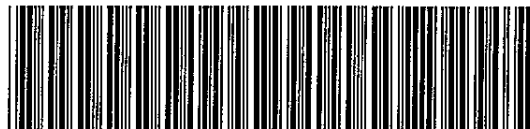

The name of this corporation shall be Diamond's Eyes Entertainment & Productions, Inc.

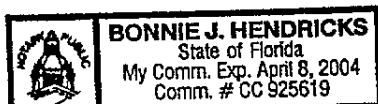
