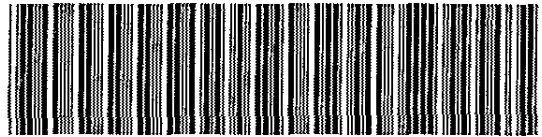

ARTICLES OF INCORPORATION

OF

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

SANTO CONSULTING SERVICES, INC.

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of the Corporation shall be Santo Consulting Services, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation is 8146 Nature's Way, Apartment 13, Bradenton, FL 34204.

ARTICLE III- GENERAL PURPOSE

The general purpose for which the Corporation is organized shall be to conduct and transact any and all lawful business authorized and not prohibited by The Florida Business Corporation Act, as the same may be, from time to time, amended.

ARTICLE IV - SHARES

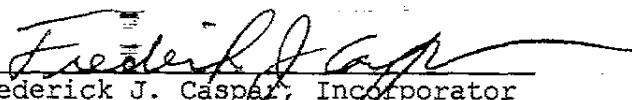
ARTICLE V - INITIAL REGISTERED OFFICE AND REGISTERED AGENT
