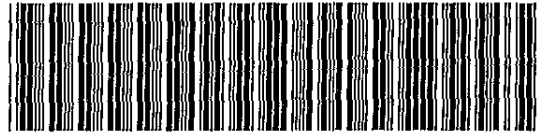



The name of this corporation is W. BROS DEVELOPMENT CORPORATION





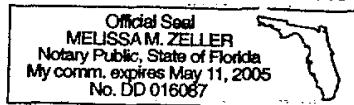
