## ARTICLES OF INCORPORATION OF

#### Article I - Name

The name of this corporation is **COASTLINE HOME FUNDING CORP.**, and the corporations principal office and mailing address of the corporation shall be 664 South Patrick Drive, Satellite Beach, Florida 32937.

#### Article II - Duration \_

This corporation shall exist perpetually. The date of commencement of corporation shall be November 25, 2002.

#### Article III - Purpose
