AMENDED AND RESTATED ARTICLES OF INCORPORATION OF MATRIX NETWORK, INC.

Pursuant to the provisions of Section 607.1008, Florida Statutes, this Florida profit corporation hereby amends and restates The Articles of Incorporation of Matrix Network, Inc. filed on December 2, 2002:

ARTICLE I Name of Corporation
