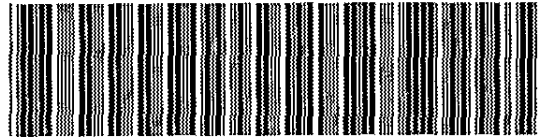



ARTICLE I

NAME

THE NAME OF THIS CORPORATION SHALL BE: GULFCOAST TRAFFIC
TICKET CLINIC, INC.

ARTICLE II

DURATION

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

ARTICLE III

PURPOSE

THIS CORPORATION IS ORGANIZED FOR THE PURPOSE OF ACTING AS
A LEGAL REFERRAL SERVICE AND FOR THE PURPOSE OF TRANSACTING
ANY AND ALL OTHER LAWFUL BUSINESS.

ARTICLE IV

CAPITAL STOCK

THIS CORPORATION IS AUTHORIZED TO ISSUE 100 SHARES OF
COMMON STOCK WITH A PAR VALUE OF \$100.00 PER SHARE.

ARTICLE V

PREEMPTIVE RIGHTS

EVERY SHARE HOLDER, UPON SALE FOR CASH OF ANY NEW

STOCK OF THIS CORPORATION OF THE SAME KIND, CLASS OR SERIES AS THAT WHICH THEY ALREADY HOLD, SHALL HAVE THE RIGHT TO PURCHASE THEIR PRO-RATA SHARE (AS NEARLY AS MAY BE DONE WITHOUT ISSURANCE OF FRACTIONAL SHARES) AT THE PRICE AT WHICH IT IS OFFERED TO OTHERS.

ARTICLE VI

REGISTERED OFFICE AND AGENT

(B) SUBJECT TO THE PROVISIONS AND CONDITIONS OF THIS
ARTICLE, THE CORPORATION SHALL HAVE THE FULL POWER AND
LAWFUL AUTHORITY TO ACCEPT PROPERTY, LABOR AND SERVICES FOR
SHARES OF STOCK IN LIEU OF CASH, AT JUST VALUATION TO BE FIXED BY
ITS BOARD OF DIRECTORS.

(C) A DIRECTOR OF THE CORPORATION MAY TRANSACT
BUSINESS, BORROW, LEND OR OTHERWISE DEAL OR CONTRACT WITH THE
CORPORATION TO THE FULL EXTENT AND SUBJECT ONLY TO THE
LIMITATIONS AND PROVISIONS OF THE LAWS OF THE STATE OF FLORIDA
AND THE LAWS OF THE UNITED STATES.

(D) THE CORPORATION SHALL INDEMNIFY EACH DIRECTOR AND

OFFICER OF THE CORPORATION AGAINST ALL AND ANY PORTION OF ANY
EXPENSES REASONABLY INCURRED BY THEM IN CONECTION WITH OR
ARISING OUT OF ANY ACTION, SUIT OR PROCEEDING IN WHICH THEY MAY
BE INVOLVED, BY REASON OF THEIR BEING OR HAVE BEEN AN OFFICER
OR DIRECTOR AT THE TIME OF INCURRING SUCH EXPENSES, TO THE FULL
EXTENT PERMITTED BY AND SUBJECT ONLY TO THE LIMITATIONS AND
PROVISIONS OF THE LAWS OF THE STATE OF FLORIDA AND THE LAWS OF
THE UNITED STATES.
