1. The Name of the professional corporation is: Educational Tools, Inc. ("Corporation").

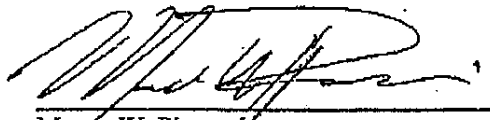
2. The date of filing of the Articles of Incorporation of the Corporation was November 25, 2002, amended January 29, 2007 and assigned document number P02000127116.
