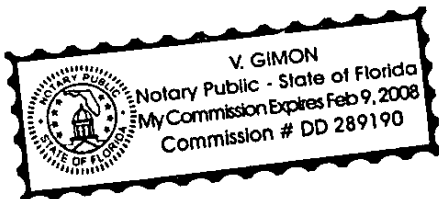
1. Matthew J. Wright is the President of MICKEY WRIGHT CAR LOCATOR, INC., a Florida corporation, (hereinafter "Corporation").
