ARTICLES OF INCORPORATION
OF

F.E. POR COLOMBIA, CORP.

ARTICLE I - NAME

The name of the corporation is **F.E. POR COLOMBIA, CORP.**

ARTICLE II- DURATION

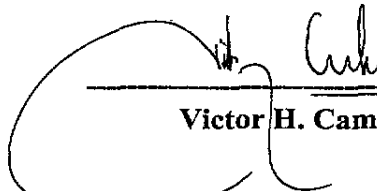

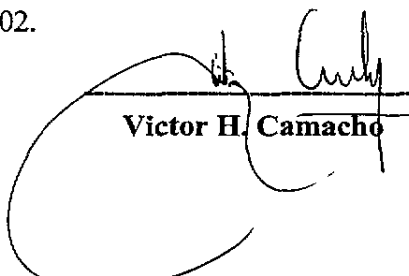
