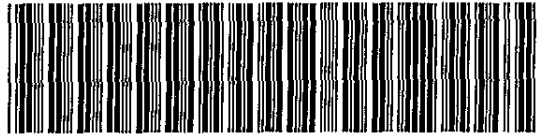

**ARTICLES OF INCORPORATION
OF
Si Simonds' Floral Boutique, Inc.**

The undersigned, acting as sole incorporator of a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be Si Simond's Floral Boutique, Inc. (the "Corporation").

ARTICLE II

The purpose for which the Corporation is organized is to engage in any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, and to exercise any and all powers that corporations may now or hereafter exercise under the Florida Business Corporation Act.
