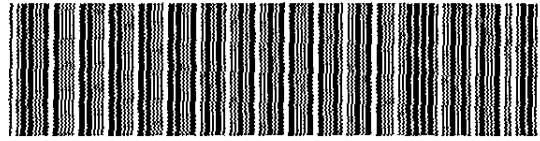

Article I - Name

The name of this corporation is: **DFK DEVELOPMENT CORP.**

Article II - Duration

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation.

Article III - Purpose

Article IV - Capital Stock

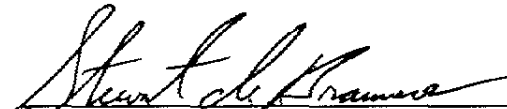

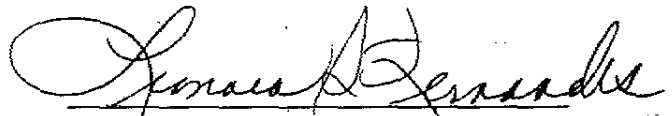

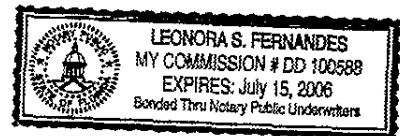
