Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation ("Articles of Amendment"):

1. The name of the corporation is Lord Clips Inc. (the "Corporation").
2. "Article I" of the Articles of Incorporation for the Corporation is amended and restated in its entirety to read as follows:


5. The Articles of Amendment were voted upon and duly approved, adopted, and ratified by the Shareholders of the Corporation on August 26, 2003.
