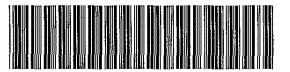

THE UNDERSIGNED incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

<u>ARTICLE I - NAME AND PRINCIPAL PLACE OF BUSINESS</u>
