ARTICLES OF INCORPORATION

FOR

DANIEL R. JONES, INCORPORATED

The undersigned subscriber to these articles of Incorporation competent to contract, hereby associates himself to form a Corporation under the laws of the STATE OF FLORIDA.

ARTICLE I

The name of this Corporation is: DANIEL R. JONES, INCORPORATED.

ARTICLE II

The general nature of the business to be conducted and transacted by this Corporation is as follows: to engage in the business of operating store facilities for the purpose of sales of beverages, refreshments, and snacks.

A. The said Corporation shall have the additional powers to:

(1) Install, rebuild, and repair the interiors and exteriors of the commercial establishment. To buy, sell, lease, rent and operate equipment, required for sale of merchandise.

(2) To hire and employ persons with qualifications essential to the performance of the business.

B. The said Corporation shall also have the power to:

(1) Conduct business in various enterprises, hold mortgages, lease, convey or otherwise dispose of real and personal property in the State of Florida and all other states and countries.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is: Seventy-five thousand shares, (75,000). of the par value of (\$1.00), One dollar per share.

ARTICLE IV INITIAL CAPITAL

The amount of Capital with which this Corporation will begin this business is Five Hundred dollars, (\$500.00).

ARTICLE V

The establishment will be equipped with required equipment and related services, including fire extinguishers, and public restroom facilities.

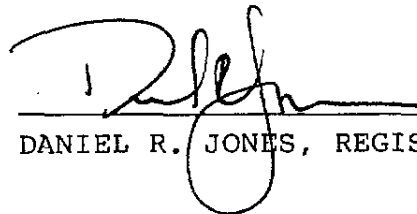

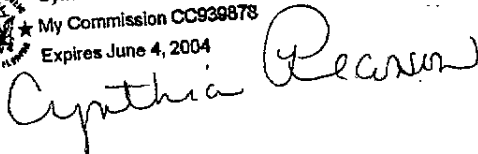
