

ARTICLE I. NAME

NAME: The name of this corporation is HIDDEN SCREENS, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 27th day of
November, 2002.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of sales and distribution of concealed, manual and motorized, screens for doors and windows and transacting any and all other lawful business in the State of Florida and the United States of America.




