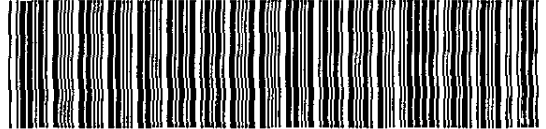

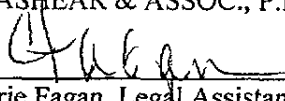

Pursuant to the provisions in Section 607.1003 of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation pursuant to a meeting of the shareholders of the Corporation duly called on November 11, 2003:

1. The following amendment to the Articles of Incorporation of Mega Publishing, Inc. was adopted by holders of a majority of the outstanding shares of the common stock of the corporation on November 11, 2003, in the manner prescribed by the Florida General Corporation Act:

ARTICLE V

Capital Stock: This Corporation is authorized to issue is 10,000 shares of \$.001 par value common stock.

2. The number of shares of the corporation outstanding at the time of such adoption was 1,400 shares common stock; and the number of shares entitled to vote thereon was 1,400 shares common stock.

3. The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:

Common	1,400

4. Number of shares voted for the amendment of Article V was 1,400; the number of shares voted against such amendment was 0; the number of shares abstaining was 0; and the number of shares not represented at the meeting in person or by proxy was 0.

5. The number of votes cast by a majority of the holders of common stock in favor of the amendment of Article V was sufficient for approval by the common stock shareholders.
