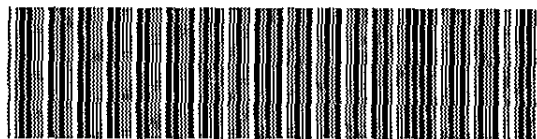

OF



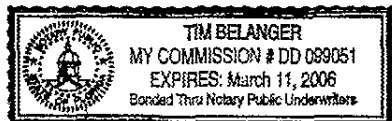


