

## AGREEMENT AND PLAN OF MERGER BETWEEN

Rangeley Lakes Corp.
(A New York Corporation)
AND

Rangeley Lakes Corp. (A Florida Corporation)

Agreement and Plan of Merger dated January <u>1</u>, 2003, between Rangeley Lakes Corp., a New York corporation, and Rangeley Lakes Corp., a Florida corporation.

#### **AGREEMENT**

In consideration of the mutual covenants set forth in this Agreement, the parties agree as follows:

- 1. In accordance with the provisions of this Agreement, the New York Business Law and the Florida Business Corporation Act, at the Effective Time, Rangeley Lakes Corp. (NY) shall be merged with an into Rangeley Lakes Corp. (FL) (the "Merger"), the separate and corporate existence of Rangeley Lakes Corp. (NY) shall cease, and Rangeley Lakes Corp. (FL) shall continue under its present name (the "Surviving Corporation"). Rangeley Lakes Corp. (NY) and Rangeley Lakes Corp. (FL) are collectively referred to as the "Constituent Corporations.").
- 2. The Merger shall become effective on April 1, 2003, the date that both a Certificate of Merger has been filed by the Secretary of State of New York and the Articles of Merger have been filed by the Secretary of State of Florida (the "Effective Time").
- 3. The Surviving Corporation shall possess and retain every interest in all assets and property of every description, wherever located of each of the Constituent Corporations. The rights, privileges, immunities, powers, franchises and authority, of a public as well as private nature, of each of the Constituent Corporations shall be vested in the Surviving Corporation without further act or deed. The title to or any interest in any real estate vested in either of the Constituent Corporations shall no revert or in any way be impaired by reason of the Merger. All obligations belonging to or due to each of the Constituent Corporations shall be vested in the Surviving Corporation without further act or deed. The Surviving Corporation shall be liable for all of the obligations of each of the Constituent Corporations existing as of the Effective Time.

4. At the Effective Time, by virtue of the Merger and without any action on the part of the parties or otherwise:

Each issued and outstanding share of the capital stock of Rangeley Lakes Corp., a New York corporation, shall be exchanged pro rata for a share of capital stock of Rangeley Lakes Corp., a Florida corporation, and the shares of stock of Rangeley Lakes Corp., a New York corporation then shall be canceled without payment of any consideration.

- 5. The Articles of Incorporation of Rangeley Lakes Corp., (FL) in effect immediately prior to the Effective Time shall remain in effect and be the Articles of Incorporation of the Surviving Corporation.
- 6. Shareholders of the Surviving Corporation who dissent from the merger may be entitled to be paid the fair value of their shares, if they comply with the provisions of the Florida Business Corporation Act regarding the rights of dissenting shareholders.
