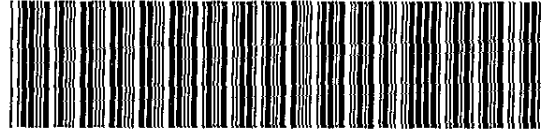

Pursuant to Chapter 621 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a professional services corporation.

ARTICLE I - NAME

The name of the corporation is Richard H. Lopez, P.A. (hereinafter called the "Corporation").

ARTICLE II - INITIAL PRINCIPAL OFFICE

The street address of the initial principal office and mailing address of the Corporation is 5201 Blue Lagoon Drive Suite 807, Miami, Florida 33126.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of providing professional legal services.
