

ARTICLES OF INCORPORATION

OF

SEDA INVESTMENTS, INC.

THE UNDERSIGNED INCORPORATOR to these Articles of Incorporation is a natural person competent to contract and form a corporation under the laws of the State of Florida, and does certify that he has become a corporation under and pursuant to the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is **SEDA INVESTMENTS**, **INC.**The principal place of business of this corporation shall be 3855 St. Armens Circle, Melbourne, Florida 32934.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all Tawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK
