## ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation  $\overline{A}$ ct, adopts the following Articles of Incorporation:

## ARTICLE I

## NAME

The name of the corporation is Elite Fashion Group, Inc. and its address is 5900 Montgomery Drive, Miami, Florida 33156.

# ARTICLE II

## DURATION

The duration of the corporation is perpetual.

### ARTICLE III

## PURPOSE

The general purposes for which the corporation is organized are:
