Resignation of Vice Pres. and Secretary-Treasurer

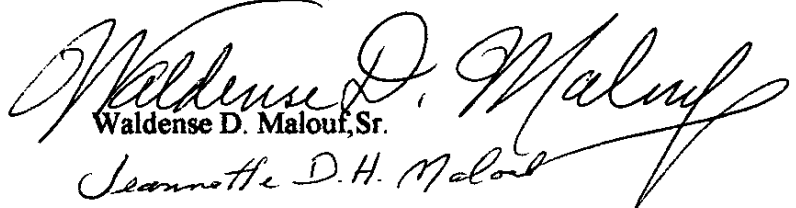
Dear Matt,

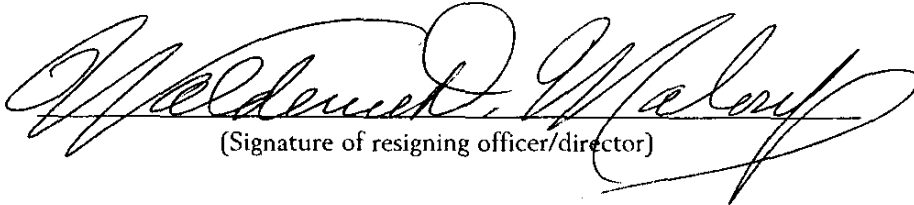
