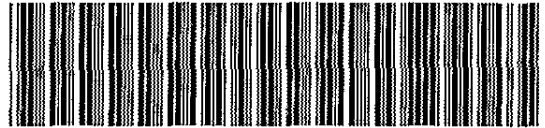

The undersigned hereby makes, subscribes, acknowledges, and files this certificate for the purpose of becoming a corporation for profit under the laws of the State of Florida.

TALLAHASSEE, FLORIDA

1. Name. The name of this corporation (the "Corporation") shall be:
RICHARD REED, OD, P.A.
2. Address. The initial street address of the principal office of this Corporation is 1662 Florence Ave, Ft. Walton Beach, FL 32547-4277, and Richard Reed, 1662 Florence Ave, Ft. Walton Beach, FL 32547, is hereby designated as resident agent for this Corporation.
3. Purpose. This Corporation is in the business of an Optometrist as permitted under the laws of the United States and of this State and of the Florida Board of Optometry.
