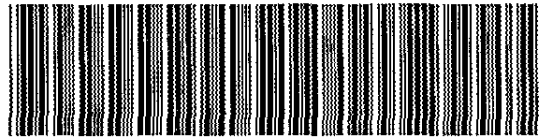

ARTICLES OF INCORPORATION

OF

Misthos Real Estate, Inc.

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of this corporation is Misthos Real Estate, Inc.

ARTICLE II

PRINCIPAL OFFICE/MAILING ADDRESS

ARTICLE III

SHARES

The number of shares the corporation is authorized to issue is 5,000 shares par value of \$1.00 per share.




