ARTICLES OF INCORPORATION
OF

The Undersigned, for the purpose of forming a Professional Corporation under the Florida Business Professional Service Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1.0 NAME AND ADDRESS

The name of the Professional Corporation is: Mark A. Hardin D.O. P.A. The principal office and mailing address is 3858 Eldridge Avenue, Orange Park, Florida, 32073-2155.

ARTICLE 2.0 DURATION

The duration of the Professional Corporation is perpetual.




