ARTICLES OF INCORPORATIONS OF

SECRETARY OF STATE TALLAHASSEE, FLORIDA

THE NEW LIFE RESIDENTIAL FACILITY, INCORPORTED

The undersigned subscribers to these Articles of Incorporation, desiring to form a corporation for profit under the law of the State of Florida, hereby execute these Articles of Incorporation for the purpose of providing for the information, liability, rights, privileges, and immunities of a corporation for profit.

ARTICLE I

Name of Corporation

The name of this corporation shall be THE NEW LIFE RESIDENTIAL FACILITY, INCORPARATED

ARTICLE II

The principal place of business of the corporation shall be in Fort Pierce, Florida, with privilege of establishing branch offices and place of business at other places within or without the State of Florida. The street address of the principal office of incorporation within the State of Florida and its initial registered office shall be 117 South 13th street, Fort Pierce, FL. 34950 provided, however, that the stockholders may from time to time move the principal office to any other address within the State of Florida. The name of its initial registered agent at its initial registered office shall be Daisy Mae Tate.

ARTICLE III

General Nature of Business

The purpose for which the corporation is organized and incorporated under the Chapter 607, Florida statutes. To provide adult residential living facility for independent living of patience that is discharged from New Horizon and various mental health facilities.

ARTICLE IV

STOCK

The authorized capital stock of this corporation shall consist of 3 shares of common stock having a par value of 100.00 per share, said 3 shares being the maximum number of shares which the corporation may issue and have outstanding at any time. All or part of the capital stock may be payable and paid for in property, real, personal, or mixed, or in labor or services, or in other consideration, as may be determined. Any and all such shares so issued shall be and constitute fully paid stock and not liable to any further call or assessment thereon, and the holder or holders of such shares shall not be liable for any future payment therefore or thereon.

ARTICLE V

Management of Corporation

The business of corporation shall be managed by its stockholders rather than by a board of directors. In the management of the business of the corporation, the act of the stockholders representing a majority of outstanding shares of the corporation entitled to vote, represented in person or by proxy, shall be entitled to vote, in person or by proxy, for each share of voting stock held by him. A majority of the outstanding shares of the corporation entitled to vote, represented in person or stockholders for the management of the business of the corporation. This corporation shall be composed of the following directors:

- 2. Financial Secretary- Linda Mae Pearson
- 3. Financial Secretary/Executive Secretary-Bernadine Lockhart Marshall

Section 1. Duties and power of Officers

ARTICLE VIII

Amendment

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved at a stockholders' meeting by a majority of the stock entitled to vote thereon, unless all stockholders sign a written statement manifesting their intention that a certain amendment of the Articles of Incorporation be made.

ARTICLE X

Special Provisions

- (a) Every stockholder, upon the sale for cash of any new stock herein authorized, shall have the right to purchase his pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is issued to others, which price may be in excess of par.
- (b) No contract or other transaction between this corporation and any other corporation, in the absence of fraud, shall be affected or invalidated by the fact that any one or more of the officers and stockholders of this corporation is or are

interested in, or is a stockholder, director or officer, or are stockholders, directors or officers, of such other corporation, and any stockholder or stockholders, officer or officers, individually or jointly, may be a party or parties to, or may be interested in any such contract or transaction of this corporation, or in which the corporation is interested, and no contract, act or transaction in the absence of fraud, shall be affected or invalidated by the fact that any stockholder or stockers, officer or officers, of the corporation is a party or are parties to or interested in such contract, act or transaction, or in any way connected with such person or persons, firm or corporation, and each and every person who may become a stockholder from any liability that might otherwise exist from thus contracting with the corporation for the benefit of himself or any firm, association or corporation in which he may have an interest. Any stockholder of the corporation may vote upon any contract or other transaction between the corporation and any subsidiary or controlled corporation without regard to the fact that he is also a stockholder or director of such subsidiary or controlled corporation.

- (c) The stockholders, in addition to choosing the president, vise president, secretary and treasurer of the corporation may choose such other officers as they shall deem advisable, and such officers shall serve for such term and have such duties as may be prescribed by the By-Laws or by resolution of the stockholders. Any person may hold two (2) or more offices, expect that the president may not also be the secretary or assistant secretary.
- (d) The stockholders shall have the power by resolution or by appropriate action inscribed in the minutes of its meetings to appoint or provide for the appointment of an executive committee, manager, or business manager, who extent provided for in said resolution or in said minutes, shall have and may exercise such powers as the stockholders grant or authorize.
