# ARTICLES OF INCORPORATION OF

#### M & F CONSTRUCTION CLEANING, INC.

OZ ORCHANO, The undersigned subscriber to these Articles of Incorporation, a native person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I. <u>NAME</u>

The name of this corporation is:

M &F CONSTRUCTION CLEANING, INC.

#### ARTICLE II. NATURE OF BUSINESS

The corporation may engage in any activities or business permitted under the laws of the United States and of the State of Florida.

The corporation shall engage, contract and or transact cleaning and janitorial services of any kind. Services shall include but not be limited to the cleaning of construction sites, residential and commercial establishments.

#### ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time shall be as follows: One Thousand (1,000) shares of common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be as fixed by the Board of Directors, and may take the form of services rendered, cash, property, or any other form deemed satisfactory by the Board of Directors. Common stock of this corporation shall be issued as "small business corporation".

## ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this corporation will begin business shall not be less than Five Hundred Dollars ( $$5\overline{0}0.00$ ).

#### ARTICLE V. TERM OF EXISTENCE

The corporation is to exist perpetually unless dissolved by law.

#### ARTICLE VI. ADDRESS

The initial street address of the principal office of the corporation in the State of Florida shall be: 7215 Woodhill Dr., Apt 214, Street, Orlando, FL 32718. The Board of Director(s) may from time to time move the principal office to any other place or places as may be designated by the Board of Directors.

## ARTICLE VII. DIRECTORS

This corporation shall have one director initially. The number of Directors may be increased or diminished from time to time, by by-laws adopted by the stockholders, but shall never be less than one.

# ARTICLE VIII. DIRECTORS' POWERS

The Board of Directors shall have the power to fix or change salaries of the Directors as Directors and as Officers, to restrict the transfer of stock by stockholders, to indemnify Directors and Officers against liability for their good faith acts and omissions to permit contracts or other transactions between the corporation and one or more of its Directors individually or business in which one or more of its Directors are interested, and to exercise such other powers of corporation as are not inconsistent with these Articles or with any by-laws that may be adopted by the stockholders.


#### ARTICLE XI. AMENDMENTS
