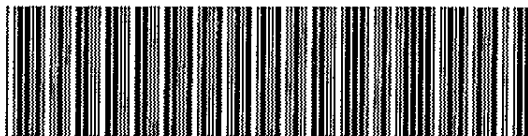

NAME



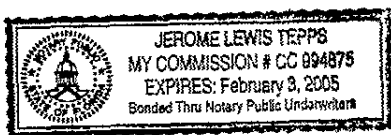
