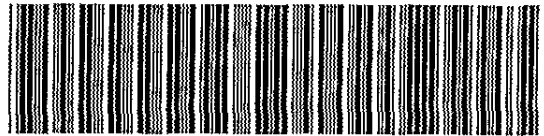

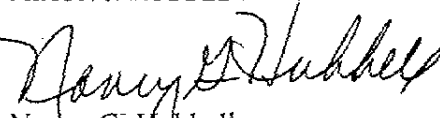

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following articles of incorporation:

ARTICLE I
NAME AND PRINCIPAL OFFICE ADDRESS

The name of the corporation shall be INTERNATIONAL FOOD CONCEPTS, INC., and the principal office and mailing address is: 245 24th Ave. SW, Ruskin, Florida 33570.

ARTICLE II
DURATION

The term of existence of the corporation shall be perpetual.

ARTICLE III
PURPOSE

The general purposes for which the corporation is organized are:

1. To engage in the business of sales and marketing of food products.
2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

These Articles of Incorporation may be altered or amended by a majority vote of the Directors of the Corporation.

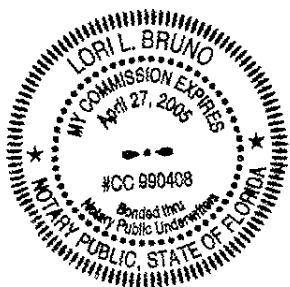
