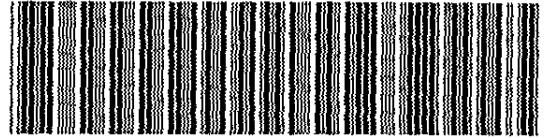

ARTICLES OF INCORPORATION  
OF

ARTICLE ONE

The name of the corporation is SUNSHINE CHIROPRACTIC CENTER, INC.
